

ELECTION TO MEMBERSHIP

Persons over twenty-one (21) years of age may be proposed and seconded by any two members of the Club. Candidates for election to membership, upon being introduced to at least three Governors, shall be nominated by the Membership Committee at a regularly scheduled meeting of the Board. New members may enter in one of the several classes of membership for which they qualify:

Resident: Persons residing or having their principal place of business within fifty (50) miles of India House. Resident members enjoy voting rights.

Transferable. Persons who otherwise qualify for Resident membership may elect Transferable membership, enabling the transfer of membership to another person, acceptable to the Membership Committee, in which event the initiation fee will be waived.

Intermediate Resident: Persons under forty (40) years of age may retain such status until the month following their fortieth birthday, when they shall become Resident members. Intermediate Resident members enjoy voting rights.

Senior: Persons sixty-five (65) years of age and over who have maintained good standing as Resident or Non-Resident members for ten (10) years and who have retired from active business or professional pursuits may become Senior Members upon written request to the Executive Committee.

Non-Resident. Persons in the United States or Canada neither residing nor having their place of business within fifty (50) miles of India House, but within the tri-state area (New York, New Jersey, Connecticut), shall be considered Non-Resident A members; outside the tri-state area persons residing in the United States shall be considered Non-Resident B members; and persons residing outside the United States and Canada shall be considered Non-Resident B members.

Upon election of a candidate, the Club Secretary shall notify the candidate, and also his or her proposer, of the fact and, upon such candidate's remitting all amounts payable upon such election, the candidate shall be welcomed to the Club with all the rights enjoyed by members of his or her membership Class.

ENTRANCE FEES AND DUES

Each new member, upon his or her admittance to the Club, shall remit a one-time entrance fee of \$1000 payable to India House Club. The child of a member in good standing for at least five years is a Legacy member, and shall have an entrance fee of \$250, and pay Intermediate dues.

Each member shall maintain good standing by remaining current in all charges, including annual dues (and applicable sales taxes) in accordance with his or her membership Class:

Resident:	\$1,585
Intermediate:	\$840
Transferable:	\$1,975
Non-Resident A:	\$840
Non-Resident B:	\$495
Senior Resident:	\$455

Annual dues are payable in advance. (All payments must add tax.) Resident, Intermediate, Transferable and Non-Resident A members may pay on a monthly basis, upon written request to the Club General Manager. Persons elected in any month other than January shall be invoiced annual dues on a pro-rata basis of the calendar months remaining in the calendar year in which such persons were elected to membership.

Spouse Benefit. Members may nominate spouses and life partners for Club privileges in accordance with House Rules, and subject to an annual fee of \$160.
